Design

An exclusive right to use a product and/or product's design, such as an object, a building and an image thereof, for a specified period of time.



Utility model

An exclusive right to practice a device relating to "the shape, structure or combination of articles" for a specified period of time.

2. Maintenance of Patent right

We will manage the payment schedule of Patent right annual fee.

3. Finding new inventions and technologies

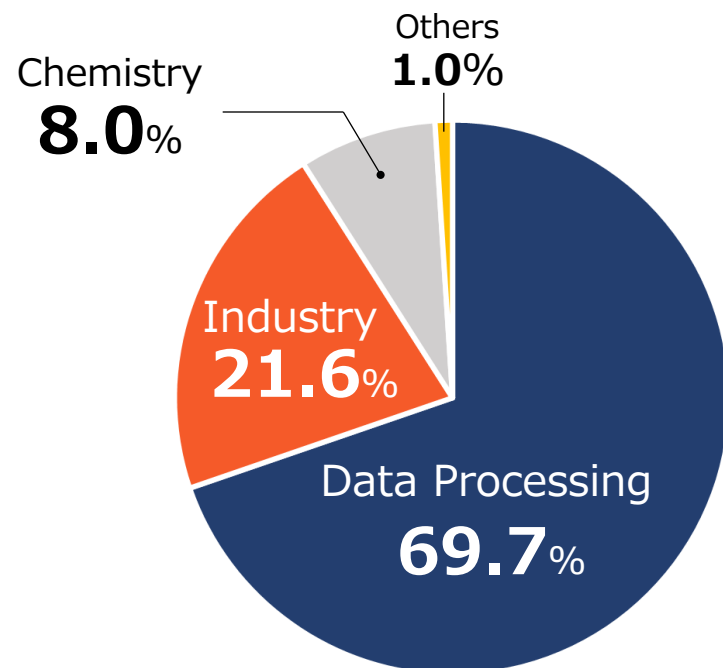

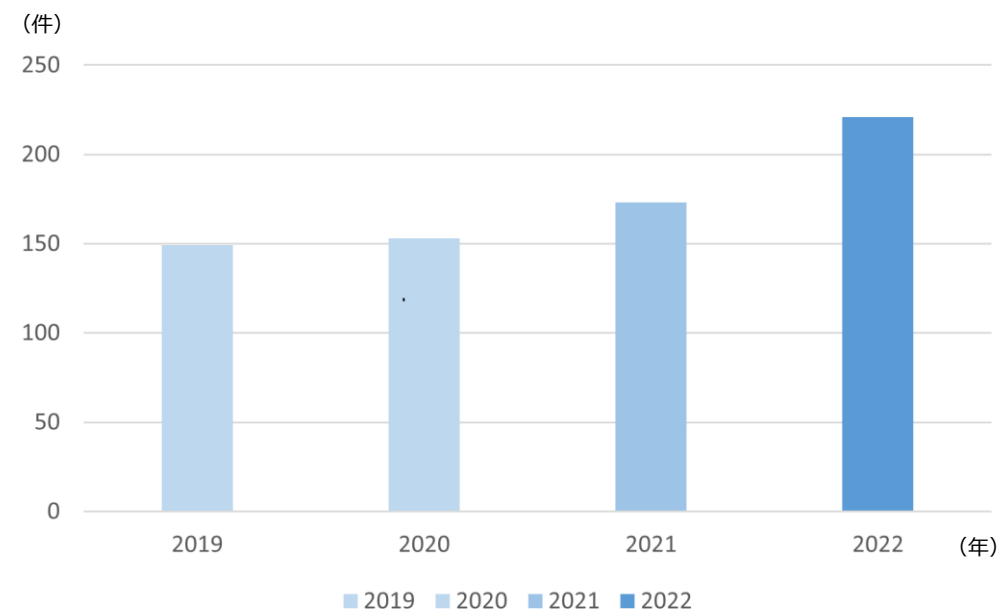
